



## THE GOVERNMENT OF THE BAHAMAS TO HOLD ANOTHER ROUND OF WTO PRIVATE SECTOR CONSULTATIONS, 18<sup>TH</sup> TO 22<sup>ND</sup> FEBRUARY, 2019

The Government of The Bahamas wishes to advise the business community that it will hold additional, **industry-specific consultations** to obtain private sector input regarding membership in the World Trade Organization. The consultations will be held from **18**<sup>th</sup> **to 22**<sup>nd</sup> **February, 2019 at the Ministry of Finance, Cecil Wallace Whitfield Centre, Cable Beach, 3<sup>rd</sup> Floor Conference Room**.

The consultations will be industry specific and are intended to inform the Government's negotiating position regarding responses received to date from WTO Members States concerning The Bahamas' Revised Goods and Services Offers, submitted to the WTO in September 2018. To that end, the input of the business community in this consultative process would be welcomed.
